Supreme Court Upholds Affordable Care Act Rule Authorizing Health Subsidies in States with Federal Exchanges

On June 25, in *King v. Burwell*, the Supreme Court in a 6-3 decision authored by the Chief Justice upheld the IRS Regulation which provided subsidies under the Affordable Care Act (ACA) to individuals in states with only federally established — as opposed to state established — American Health Benefit Exchanges. At issue in the case was whether the phrase “established by a state” or “established by the state,” as used in the ACA § 1311 & IRC § 36B(b) respectively, should be given its ordinary and plain meaning as petitioners suggested, or be read as a term of art as the government

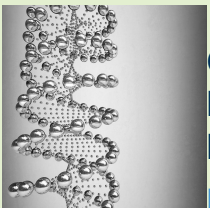

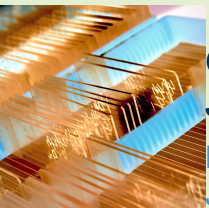

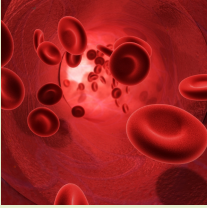
