In addition to being admitted to practice in all Florida state and federal trial and appellate courts, the U.S. Supreme Court, U.S. Tax Court and the U.S. Court of Federal Claims, Fred was admitted to the Roll of Solicitors of the Senior Courts of England and Wales in 2011. He is currently a Fellow of the American Bar Foundation, an honor limited to one-third of one percent of attorneys in America.

Active within many nonprofit organizations statewide, Fred is Chair of the Barbara Bush Foundation for Family Literacy and a Board Member of the Holocaust Documentation and Education Center, where he also serves on the Board of Directors Executive Committee.

He is a member of the Florida State University College of Law Board of Visitors and served two terms on the Florida State University Foundation Board of Trustees.
