BMA, Greenberg, Shearman and Stocche Forbes guide Gerdau issue

[Greenberg Traurig LLP](#) in New York and Northern Virginia and [BMA - Barbosa, Müssnich, Aragão](#) in São Paulo have helped Brazilian steelmaker Gerdau issue US\$650 million in bonds.

The initial purchasers turned to Shearman & Sterling LLP in New York, Washington, DC and San Francisco and [Stocche Forbes Advogados](#) in São Paulo for the offering, which closed on 24 October.

The initial purchasers also offered to buy up to US\$500 million of Gerdau's outstanding debt.

Last September, BMA acted as deal counsel in a 450 million reais (US\$150 million) debentures [offering](#) by the steelmaker.

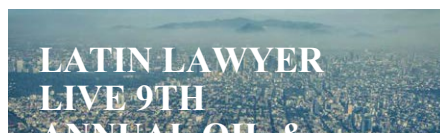
