#### **COVID-19's Impact**

- Current Impact in the U.S.:
  - The CDC has counted COVID-19 cases across all 50 U.S. states, including the District of Columbia
  - CDC Case Update Monday, March 23:
    - Total cases: 33,404 (+18,185 since Friday, March 20)
    - Total deaths: **400** (+199 since Friday, March 20)
  - States with highest number of confirmed cases:
    - New York 16,916
    - Washington State 1,996
    - New Jersey 1,914
    - California 1,816
    - Florida 1,171



# Requirements

#### Federal OSHA

- General Duty Clause
- Personal Protective Equipment (PPE) Standard
- Recording and Reporting Occupational Injuries
  - Confirmed Case
  - Work Related Key Criteria
    - As a result of their work related duties
    - Common cold for flu NOT Recordable
    - TB, Hep A, plague ARE Recordable
  - Good Faith Standard
    - Was the exposure work related or incidental
  - Hospitalization/Death notify OSHA within 24/8 hours
    - Work related?

#### Requirements

- Cal OSHA
  - Aerosol Transmissible Disease (ATD) Standard
  - Who is Covered?
    - Hospitals and other medical facilities including transport
    - Labs
    - Other government, jails, shelters
  - What is Required?
    - ATD Exposure Control Plan
    - Training
    - Engineering & Work Practice Controls
    - Personal Protective Equipment
      - N95 Respirators
      - PAPRs



# Consideration

- Adapt Cal-OSHA ATD Standard for All Workplaces
- Exposure Control Plan
  - Source
  - Decontamination
- Work Practice Controls
  - Identify specific measures (hand washing, surface cleaning, etc)
- Training
  - Use current training systems
- PPE Not Applicable


