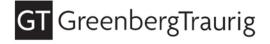

### Q&A WITH DANIELLA GENET SILBERSTEIN

# Are you active in any programmes or initiatives within your organisation? To what extent have you found this work rewarding and fulfilling?

♦ As co-chair of Greenberg Traurig's Miami Women's Initiative for the last four years, I focus on creating avenues for young lawyers to find mentors, access resources and talk openly about the unique challenges they face, especially in areas like business development. Throughout my career, I have been fortunate to have strong women role models, including my mother, who maintained an active commercial real estate legal practice while raising five children. Her example instilled in me a deep commitment to supporting and empowering the next generation of lawyers. I believe that each generation can make it a little easier for the next. I try to use my experience to help younger lawyers find proven paths rather than reinventing the wheel. My hope is that when I look back, I can say I helped create opportunities and supported others so they can do the same for those who follow.

# Could you describe the ways in which your firm has supported your career development?

♦ My experience at Greenberg Traurig has been defined by extraordinary support from the very beginning. I have always felt empowered to shape my own path while also having the support of a collaborative team.
